With reference to current report of Silvair, Inc. (the "**Company**") No. 9/2023 dated 7 April 2023, the Company hereby announces that on 11 April 2023 the Company received information that the Management Board of the Warsaw Stock Exchange (the "**WSE Management Board**") had adopted resolution No. 314/2023 of 11 April 2023 (the "**Resolution**") pursuant to which the WSE Management Board had resolved to:

- 1) introduce, as of 13 April 2023, to trading on the parallel market of 1,607,908 ordinary bearer shares in the Company with a nominal value of USD 0.10 each (the "**Shares**"), registered by the National Depository for Securities (*Krajowy Depozyt Papierów Wartościowych S.A.*) under ISIN code USU827061099; and
- 2) list the Shares in the continuous trading system:
 - a) in the listing class referred to in § 71 item 5) of Section IV of Detailed Stock Exchange Trading Rules in the UTP system;
 - b) under an abbreviated name of "SILVAIR-REGS" and a ticker of "SVRS".

Trading in the Shares is subject to restrictions under U.S. securities laws under Category 3 of Regulation S under the United States Securities Act of 1933, described in detail in Part A (Category 3 of Regulation S) of Exhibit 14 to the WSE Detailed Exchange Trading Rules in UTP System and in the joint statement of the Company and the relevant investment firm, posted on the website of the Warsaw Stock Exchange ("**WSE**").

The information provided in the List of the Warsaw Stock Exchange (*Cedula Giełdy Warszawskiej*) and on the WSE website regarding the quotation of the Company's financial instruments will be marked in a special way specified in the Resolution.

The Resolution came into force on the date of its adoption.
